No private party transactions are acceptable.

This grant is open to Yolo Commute Member Employees and Capitol Yards Residents. One application per employee (If you were awarded last year recipients are not eligible for a bike purchase this year) or Capitol Yards resident.

YCTD employees are not eligible for this program. Incomplete or multiple applications may result in disqualification.

Yolo Commute reserves the right to determine validity of estimate provided, and whether a vendor is an acceptable retailer.

If grant is awarded, grantee will need to complete their purchase, and then submit receipt for reimbursement by May 31, 2022.

This grant is a pilot program and does not guarantee future funding. Totality of grant awards is not to exceed \$4,500.00 and is subject to no more than \$200.00 per individual.

Yolo Commute reserves the right to cancel or modify this program at any time.

Deadline for submissions is 5:00pm PST 5/31/2022.

Grantees will be notified on or before 6/30/2022.
